A COUNCIL BILL

TO APPROVE Jones Academy's Handbooks for School Year 2016-17.

WHEREAS, Jones Academy is an Indian Boarding School operated by the Choctaw Nation of Oklahoma under public law 100-297 Tribal Continuation School Act; and


WHEREAS, each year Jones Academy is required to update the policy and procedures pertaining to employee and student/parent regulations for day to day operation of the school; and


WHEREAS, the policy and procedures must be approved by the Council and Chief in order to become binding.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for the employee and student/parent handbooks for Jones Academy's Residential Program and Elementary School for school year 2016-17.

CERTIFICATION
