TO APPROVE the rescission of CB-100-92 and CB-097-97.


WHEREAS, CB-100-92 and CB-097-97 are hereby rescinded.


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for the rescission of CB-100-92 and CB-097-97.

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

MAY 9, 1992

Charley Jones introduced the following

A COUNCIL BILL

A Council Bill limiting contributions to various individuals and organizations.

As the Choctaw Nation grows, there are numerous individuals and organizations seeking financial assistance for many purposes.

Any contributions to any group or organization shall be for the benefit of all ten and one half counties in the Choctaw Nation only.

Any contribution for students or scholars is to be limited to \$300.00. The students or scholars are to have an A or B average. If the money is not used for the purpose requested, the money is to be returned to the Tribe.

If the contribution is used, the individual will give an oral or written report to the Tribal Council and Tribal Administration.


Any contributions will be considered only if the money is available from the General Fund.


Be it enacted by the Tribal Council of the Choctaw Nation of Oklahoma, that this Act be sited for approval for limiting contributions to various individuals and organizations.

WHEREAS, the number of request for funding of extra curricular activities is outgrowing the request for Educational activities, and


WHEREAS, the Choctaw Nation feels that Education and Academics funding of our Indian children is necessary for their future and wishes to continue this practice, and


WHEREAS, the Choctaw Nation has decided to discontinue funding request other than above stated at this time.


