

TO APPROVE GRAZING LEASE NO. G09-1875 IN FAVOR OF KEVIN BURCH ON LAND USA IN TRUST FOR THE CHOCTAW NATION OF OKLAHOMA, IN LATIMER COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

ANTHONY DILLARD INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE Grazing Lease No. G09-1875 with Kevin Burch, in Latimer County, OK.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, Kevin Burch has proposed a Grazing Lease on land USA in Trust for the Choctaw Nation of Oklahoma described as the SE¼ SE¼ of Section 14; NE¼ NE¼ of Section 23; and SW¼ SW¼ of Section 13, all in Township 4 North, Range 17 East, Latimer County, OK, containing 90 acres, more or less; and

WHEREAS, the lease will be for a term of three (3) years beginning January 1, 2016, and expiring December 31, 2018. He will pay annual rental in the amount of \$1,105.00. In addition to the rental payment, Mr. Burch has agreed to do brush and weed control on 50 acres of open land by the use of brush hog or chemical spray at a value of \$1,000.00 per year.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval of proposed Grazing Lease No. G09-1875 with Kevin Burch on land USA in Trust for the Choctaw Nation of Oklahoma located in Latimer County, Oklahoma.

CERTIFICATION

I, the undersigned, as Speaker of the Tribal Council of the Choctaw Nation of Oklahoma, do hereby certify that the Tribal Council is composed of twelve (12) seats. Eight (8) members must be present to constitute a quorum.
