

TO APPROVE GRAZING LEASE NO. G09-1878 IN FAVOR OF FRED JAMES, JR. ON LAND USA IN TRUST FOR THE CHOCTAW NATION OF OKLAHOMA, IN LATIMER COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

ANTHONY DILLARD INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE Grazing Lease No. G09-1878 with Fred James, Jr., in Latimer County, OK.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, Fred James, Jr., has proposed a Grazing Lease on land USA in Trust for the Choctaw Nation of Oklahoma described as Lots 3 and 4; NE¼ SW¼; SE¼ SW¼; N½ SE¼; SW¼ SE¼ in Section 18; Lot 1; NW¼ NE¼; and NE¼ NW¼ in Section 19; all in Township 4 North, Range 19 East, Latimer County, OK, containing 380 acres, more or less; and

WHEREAS, the lease will be for a term of three (3) years beginning January 1, 2016, and expiring December 31, 2018. He will pay annual rental in the amount of \$1,505.00. In addition to the rental payment, Mr. James has agreed to the improvements listed on "Attachment A".

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval of proposed Grazing Lease No. G09-1878 with Fred James, Jr. on land USA in Trust for the Choctaw Nation of Oklahoma located in Latimer County, Oklahoma.

CERTIFICATION
