

TO APPROVE BUSINESS LEASE NO. G09-1880 IN FAVOR OF LAKE EUFAULA ROD & GUN CLUB ON LAND USA IN TRUST FOR THE CHOCTAW & CHICKASAW NATIONS, IN PITTSBURG COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION
ANTHONY DILLARD INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE Business Lease No. G09-1880 with Lake Eufaula Rod & Gun Club, in Pittsburg County, OK.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, Lake Eufaula Rod & Gun Club has proposed a Business Lease on land USA in Trust for the Choctaw & Chickasaw Nations described the SE¼ SE¼ NW¼ NE¼; SW¼ SW¼ NE¼ NE¼ of Section 26, Township 6 North, Range 14 East, Pittsburg County, OK, containing 5 acres, more or less; and


WHEREAS, the lease will be for a term of three (3) years beginning January 1, 2016, and expiring December 31, 2018. They will pay annual rental in the amount of \$100.00. In addition to the rental payment, brush and weed control will be performed on 5 acres of open land by the use of brush hog or chemical spray at a value of \$100.00 per year; a Commercial Liability Insurance policy will be required, estimated cost of \$700 per year; 30 tons of 1½ inch crusher run gravel will be added from entry gate to rest shelter/Administrative area with an estimated value of \$750.00; general facility maintenance and upkeep will be performed; and the entry gate will be replaced with a new 16 ft. metal tubular gate at property entrance, value of \$200.00.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval of proposed Business Lease No. G09-1880 with Lake Eufaula Rod & Gun Club on land USA in Trust for the Choctaw & Chickasaw Nations located in Pittsburg County, Oklahoma.

CERTIFICATION
