A COUNCIL BILL

TO APPROVE the funds and budget from the United States Department of Health and Human Services, Indian Health Service, for Year Six of Six Continuation for the Domestic and Sexual Violence Prevention Initiative - Project Homakbi Ribbon.

WHEREAS, the Tribal Council approved the application of Year One of Project Homakbi Ribbon in CB-128-15, funds and budget for Year One in CB-17-16, application of Year Two Continuation in CB-96-16, funds and budget for Year Two Continuation in CB-09-17, funds and budget for Year Three Continuation in CB-16-18, funds and budget for Year Four Continuation in CB-26-19, and funds and budget for Year Five Continuation in CB-05-20.

WHEREAS, the Choctaw Nation of Oklahoma has been awarded a grant by the U.S. Department of Health and Human Services, Indian Health Service, for budget period September 30, 2020 through March 31, 2022, in the amount of \$210,000 to expand outreach and awareness of domestic and sexual violence among Native Americans for an additional year beyond the Five Years planned for Project Homakbi Ribbon. See Exhibit A;

WHEREAS, the federal budget for Year 6 of Project Homakbi Ribbbon is \$210,000 with no match; and

WHEREAS, funds for Project Homakbi Ribbon expands crisis intervention, counseling, advocacy, and behavioral health treatment, promotes community education for youth and adults, enhances domestic and sexual violence intervention and prevention, and implements trauma informed care.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept Two Hundred Ten Thousand Dollars 00/100 (\$210,000.00) from the United States Department of Health and Human Services, Indian Health Service, for Year Six of Six of the for the Domestic and Sexual Violence Prevention Initiative - Project Homakbi Ribbon for budget period September 30, 2020 through March 31, 2022.
