**RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** the funds and budget from the United States Department of Education for the Year Three of Three Continuation and Supplemental Award of the Native American Career and Technical Education Program (NACTEP).

**WHEREAS**, Tribal Council approved Year One funds and budget in CB-32-19 and Year Two funds and budget in CB-50-20 for the Native American Career and Technical Education Program (NACTEP);

**WHEREAS**, the Choctaw Nation (the "Nation") has been awarded a grant by the U.S. Department of Education (ED) for budget period October 1, 2020 through September 30, 2021, for the NACTEP, in the amount of \$482,952.00, to improve career and technical education programs that benefit Native Americans. See Exhibit A;

**WHEREAS**, the federal budget for Year 3 is \$482,952.00 with no required match;

**WHEREAS**, the Nation has also been awarded a Year 3 Supplemental grant by the ED for budget period October 1, 2020 through September 30, 2022 in the amount of \$31,228.00. See Exhibit A;

**WHEREAS**, the federal budget for both awards is \$514,180.00 with no required match; and

**WHEREAS**, funds for NACTEP provide Native Americans with high-quality career training and technical education. This training and education focus on science, technology, engineering, and math programs that result in industry-recognized credentials, certificates, or degrees. The goal of this program is to prepare participants to secure employment in high-growth, high demand occupations.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept Four Hundred Eighty-Two Thousand Nine Hundred Fifty-Two Dollars and 00/100 (\$482,952.00) for Year 3 of the Native American Career and Technical Education for budget period October 1, 2020 through September 30, 2022.


**BE IT FURTHER ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept Thirty-One Thousand Two Hundred Twenty-Eight Dollars and 00/100 (\$31,228.00) for the Year 3 Supplemental of the Native American Career and Technical Education for budget period October 1, 2020 through September 30, 2022 for a combined Year Three total of Five Hundred Fourteen Thousand One Hundred Eighty Dollars and 00/100 (\$514,180.00).
