A COUNCIL BILL

TO APPROVE the application to the United States Department of Health and Human Services, Indian Health Service, for the FY22 Domestic Violence Prevention Program (DVP).

WHEREAS, the Choctaw Nation (the "Nation") seeks funding from the United States Department of Health and Human Services, Indian Health Services, Domestic Violence Prevention Program (DVP) to help provide domestic violence education to community members and high risk populations;

WHEREAS, the maximum federal budget for Year 1 of DVP will not to exceed \$200,000.00 with no required match;

WHEREAS the maximum federal budget for Years 1 through 5 of DVP will not exceed \$1,000,000.00; and

WHEREAS, funds for the FY22 DVP will help continue the Chi Hullo Li Women's Self-Defense classes to educate on self-defense, education on consent, self-esteem, domestic violence survivor resources, and human trafficking. Funds will also be used to provide healthy relationship training materials to area schools to educate against abusive relationships, bullying, and provide bystander empowerment education.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to apply to the United States Department of Health and Human Services, Indian Health Service, for the FY22 Domestic Violence Prevention Program.

BE IT FURTHER ENACTED by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
