**RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** the application to the United States Department of Health and Human Services, Indian Health Service, for the FY22 Behavioral Health Integration Initiative (BH2I).

**WHEREAS**, the Choctaw Nation of Oklahoma seeks to apply for the Behavioral Health Integration Initiative (BH2I) (the "Grant");

**WHEREAS**, the Grant will provide licensed mental health providers in the McAlester, Idabel, and Durant locations;

**WHEREAS**, the maximum federal budget for Year 1 of the Grant will not exceed \$400,000 and there is no required match;

**WHEREAS** the maximum federal budget for Years 1 through 5 of the Grant will not exceed \$2,000,000.00; and

**WHEREAS**, funds from the Grant for FY22 will continue the previous program activities to assist patients in mental health crisis, provide mental health referrals, facilitate in-patient referrals, and train medical providers on mental health topics.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to apply to the United States Department of Health and Human Services, Indian Health Service for the FY22 Behavioral Health Integration Initiative.

**BE IT FURTHER ENACTED** by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
