# IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

TO APPROVE the Ownership Transfer of Certain Tribal Assets.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Tribal Council of the Nation (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS, the Nation owns certain wireless/broadband assets in McAlester, Oklahoma, as more particularly set out in Schedule A attached hereto and incorporated herein by reference (collectively, the "Assets"); and

WHEREAS, the Council has determined that it is in the best interests of the Nation to transfer its ownership interests in the Assets to a third party (the "Transferee") in connection with the termination of certain agreements between the Nation and the Transferee.

**THEREFORE BE IT ENACTED** by the Council that this Bill be cited as approval for the transfer of the ownership of the Assets to the Transferee, on such terms and conditions as agreed to by the Chief of the Nation or his designee.
