

TO AMEND CB-84-22: A COUNCIL BILL TO APPROVE APPLICATION FOR THE FY22 ZERO SUICIDE INITIATIVE

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO AMEND COUNCIL BILL CB-84-22 by amending paragraph 2 by striking locations "Poteau" and "McAlester" and replacing with "Hugo" and "Talihina" and by inserting paragraph 9 to CB-84-22 to include language required by the Notice of Funding Award.

WHEREAS, the Tribal Council passed CB-84-22 on January 8, 2022. See Exhibit A;

WHEREAS the Choctaw Nation Health Services Authority (the "CNHSA") wishes to amend paragraph 2 of CB-84-22 by striking locations "Poteau" and "McAlester" and replacing with "Hugo" and "Talihina". This amendment reflects the accurate locations that CNHSA will place licensed mental health providers if awarded funds;

WHEREAS the Choctaw Nation also wishes to amend CB-84-22 by inserting paragraph 8 that states: "The Choctaw Nation expresses a bona fide commitment to a Zero Suicide model within the health and behavioral health care system."

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to amend CB-84-22 as follows:

Paragraph 2: "WHEREAS the Choctaw Nation of Oklahoma seeks to apply for the FY22 Zero Suicide Initiative (the "Grant") to provide licensed mental health providers in the Poteau-Hugo and McAlester Talihina locations;"

Insert Paragraph 9: "BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval that the Choctaw Nation is committed to the Zero Suicide Model within the Behavioral and Health Care System."

The proposes amendment also inserts language required by the federal grant that was not in the original bill.

A COUNCIL BILL

TO APPROVE the application to the United States Department of Health and Human Services, Indian Health Service, for the FY22 Zero Suicide Initiative.

WHEREAS the Choctaw Nation of Oklahoma seeks to apply for the FY22 Zero Suicide Initiative (the "Grant") to provide licensed mental health providers in the Poteau and McAlester locations;

WHEREAS the maximum federal budget for Year 1 of the Grant will not exceed \$300,000.00 and there is no required match;

WHEREAS the maximum federal budget for Years 1 through 5 of the Grant will not exceed \$1,500,000.00; and


WHEREAS funds from the Grant will continue the work and progress funded by the FY17 Substance and Mental Health Services Administration Zero Suicide program that is ending September 2022. The Zero Suicide program assists patients in mental health crisis, provides mental health referrals, facilitates in-patient referrals, and trains medical providers on mental health topics.


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to apply to the United States Department of Health and Human Services, Indian Health Service, for the FY22 Zero Suicide Initiative.

BE IT FURTHER ENACTED by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
