RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE application to the American Rescue Plan Act, Emergency Grants for Native American Language Preservation and Maintenance.

WHEREAS, the Choctaw Nation (the "Nation") realizes that our Choctaw language and culture is at a critical point due to the number of Elders and language speakers that have died as a result of the COVID-19 virus;

WHEREAS, the Nation will utilize this grant opportunity in an emergency response approach to conduct community assessments, interviews with Elders, document and transcribe these interviews toward preserving the language and culture;

WHEREAS, the Nation intends to conduct this emergency language protection project through our Choctaw Language Department, Research Department, Information Technology Department, and contractual services; and

WHEREAS, the Nation intends to apply for up to \$82,609.00 with no required match.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for application to the American Rescue Plan Act (ARPA), Emergency Grants for Native American Language Preservation.

BE IT FURTHER ENACTED by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
