WHEREAS, on February 23, 1998, CB-60-98 was enacted establishing the Choctaw Nation of Oklahoma Color Guard (the "Color Guard"). See Exhibit A;

WHEREAS, the Color Guard performs duties such as the posting of colors, parade marches, and other tribally sanctioned events;

WHEREAS, the Color Guard has also been asked to provide other services such as Choctaw Veteran funerals, full military burial honors, and proper acceptance of POW and KIA remains; and

WHEREAS, the Tribal Council finds it is in the best interest of the Choctaw Nation to rename the Color Guard to the Choctaw Nation of Oklahoma Honor Guard to reflect the additional duties performed.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to rename the Choctaw Nation of Oklahoma Color Guard to the Choctaw Nation of Oklahoma Honor Guard, effective immediately.

TO APPROVE FUNDING FOR A TRIBAL COLOR GUARD

WHEREAS, the Choctaw Nation of Oklahoma wishes to establish and maintain a Tribal color guard to participate in Officially Sanctioned Tribal activities; and

WHEREAS, it is necessary for this Tribal color guard to purchase required items such as uniforms, boots, headgear, flags, staffs, pistol belts, rifles, etc.; and

WHEREAS, travel is required to participate in these events, it shall be necessary to allow for mileage reimbursement to the participating members of this Tribal color guard at the established mileage rate used by the Choctaw Nation of Oklahoma, plus a stipend of \$25.00 per day;

THEREFORE, BE IT ENACTED BY THE Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval of establishing the Tribal color guard and funding of \$20,000.00, per year, from the Motor Fuel Tax Allocation Funding to pay for the above stated purposes.
