A COUNCIL BILL

TO APPROVE the funds and budget from the Department of Homeland Security, Federal Emergency Management Agency for the FY21 Tribal Homeland Security Grant Program.

WHEREAS, the Choctaw Nation (the "Nation") has been awarded a grant from the Department of Homeland Security (DHS), Federal Emergency Management Agency (FEMA), for budget period September 1, 2021 through August 31, 2024, in the amount of \$745,646. The grant will allow the Choctaw Nation Public Safety to secure resources and training necessary to mitigate, plan for, respond to, and recover from all threats and hazards specific to our jurisdiction to ensure resiliency for the Nation and the whole community. See Exhibit A;

WHEREAS, the federal budget for the FY21 Tribal Homeland Security Grant Program (THSGP) is \$745,646 with no match required; and

WHEREAS, funds from FY21 THSGP will provide much needed equipment for emergency management and tribal first responders.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept Seven Hundred Forty-Five Thousand Six Hundred Forty-Six Dollars and 00/100 (\$745,646.00) from the Department of Homeland Security, Federal Emergency Management Agency for the FY21 Tribal Homeland Security Grant Program for budget period September 1, 2021 through August 31, 2024.
