IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the Sale of Bourg Booklet Makers Located at Choctaw Print Services in Durant, Oklahoma.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Tribal Council of the Nation (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS, the Nation, through Choctaw Print Services, has used Bourg booklet makers (the "Assets") that are broken, obsolete, have exceeded their useful life or simply no longer have a use to the Nation and that need to be disposed of in accordance with Nation Policy FA-101;


WHEREAS, the Nation has located a potential buyer (the "Buyer") that is willing to purchase the Assets for Twenty Thousand Dollars (\$20,000); and


WHEREAS, the purchase of the Assets includes the Buyer packing, crating and removing the Assets from the Nation's premises.

THEREFORE, BE IT ENACTED by the Council that this Bill be cited as approval for the sale of the Assets to the Buyer for Twenty Thousand Dollars (\$20,000), with the proceeds from such sale being credited back to Choctaw Print Services.

CERTIFICATION
