#### A COUNCIL BILL

**TO APPROVE** application to the United States Department of Justice, Office of Justice Programs for the Smart Prosecution – Innovative Prosecution Solutions Grant Program.

WHEREAS, the Choctaw Nation realizes the need to update the tribal prosecution case management system;

WHEREAS, the Choctaw Nation Prosecutors Office anticipates an influx of new cases;

WHEREAS, the current tribal prosecution case management system needs an update in order to accommodate cases more efficiently;

WHEREAS, funds from the United States Department of Justice will assist the Choctaw Nation in purchasing a new case management system for the Choctaw Nation Tribal Prosecution Office to manage cases and interface with the Choctaw Nation Justice Center and Tribal Courts; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma finds it is in the best interest of the Choctaw Nation to approve application to the United States Department of Justice, Office of Justice Programs, for the Smart Prosecution-Innovative Prosecution Solutions Grant Program.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for application to the United States Department of Justice for the Smart Prosecution – Innovative Prosecution Solutions Grant Program.
