

TO APPROVE THE FUNDS AND BUDGET FOR THE FY20 AND FY21 TRIBAL HISTORIC PRESERVATION OFFICE GRANTS (THPO)

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the funds and budget from the Department of Interior, National Park Service for the FY20 and FY21 Tribal Historic Preservation Office grants.

WHEREAS, the Choctaw Nation (the "Nation") has been awarded a FY20 grant from the Department of Interior ("DOI"), National Park Service ("NPS") for budget period October 1, 2019 through September 30, 2021 in the amount of \$68,344.00 ("FY20 Award"); See Exhibit A;

WHEREAS, the Nation has also been awarded an FY21 grant from the DOI, NPS for budget period October 1, 2020 through September 30, 2022 in the amount of \$72,553.00 ("FY21 Award"). See Exhibit B;

WHEREAS, the budget for the FY20 THPO is \$68,344.00 with no required match;

WHEREAS, the budget for the FY21 THPO is \$72,553.00 with no required match; and

WHEREAS, the combined budget for the FY20 Award and FY21 Award is \$140,897.00 and will be used to maintain the Tribal Historic Preservation office and activities.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept Sixty-Eight Thousand Three Hundred Forty-Four Dollars (\$68,344.00) from the Department of Interior, National Park Service for the FY20 Tribal Historic Preservation Office grant for budget period October 1, 2019 through September 30, 2021.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept Seventy-Two Thousand Five Hundred Fifty-Three Dollars (\$72,553.00) from the Department of Interior, National Park Service for the FY21 Tribal Historic Preservation Office grant for budget period October 1, 2020 through September 30, 2022.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma, that this Bill be cited as approval of the budgets listed in Exhibits A and B for the use of the Tribal Historic Preservation Office.


CERTIFICATION
