IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the funds and budget from the National Endowment of the Arts FY20 Arts Engagement Grant.

WHEREAS, the Choctaw Nation (the "Nation") has been awarded a grant from the National Endowment of the Arts ("NEA") for budget period July 20, 2021 through May 31, 2022, in the amount of \$10,000.00.

WHEREAS, this award will support expansion of the established Choctaw Artist Registry and include a Choctaw Youth Artist Registry. See Exhibit A;

WHEREAS, the budget for the Arts Engagement Grant is \$10,000.00 with a \$10,000 required match for a total of \$20,000; and

WHEREAS, funds for the Arts Engagement Grant will be used for planning, identification of artists, travel, community compensation, consultation and workshop/art supplies for the grant project.


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept Ten Thousand Dollars (\$10,000.00) from the National Endowment of the Arts FY20 Arts Engagement Grant for budget period July 20, 2021 through May 31, 2022.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to provide a match of Ten Thousand Dollars (\$10,000.00) for a total budget of Twenty Thousand Dollars and 00/100.

CERTIFICATION
