**RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** the funds and budget from the Oklahoma State Department of Health for the OSDH Crisis Emergency Response to COVID-19 Subaward.

**WHEREAS**, the Choctaw Nation (the "Nation") has been awarded a grant from Oklahoma State Department of Health (OSDH) for budget period June 4, 2020 through June 14, 2021, in the amount of \$129,360.00 to purchase equipment and supplies necessary to battle the COVID-19 Pandemic. See Exhibit A;


**WHEREAS**, the budget for the OSDH Crisis Emergency Response to COVID-19 Subaward is \$129,360.00 with no required match; and


**WHEREAS**, funds for the OSDH Crisis Emergency Response to COVID-19 Subaward will be used to purchase HV/AC units for tents, ventilators, and testing kits related to the COVID-19 Pandemic.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept One Hundred Twenty-Nine Thousand Three Hundred Sixty Dollars and 00/100 (\$129,360.00) from the Oklahoma State Department of Health for the OSDH Crisis Emergency Response to COVID-19 Subaward for budget period June 4, 2020 through June 14, 2021.
