RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE application to the United States Department of Housing and Urban Development for the Tribal Housing and Urban Development, Veterans Administrative Supportive Housing Grant.

WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") realizes the need to provide subsidized rental assistance for Native American Veterans who are at-risk of or currently experiencing homelessness;


WHEREAS, funds from the United States Department of Housing and Urban Development (HUD) will assist the Choctaw Nation by allowing for rental vouchers for those confirmed to be eligible by the U.S. Veterans Administration (VA); and

WHEREAS, the Tribal Council finds it is in the best interest of the Nation to approve application to the HUD-Veterans Administration-Supportive Housing Grant (VASH).


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that a Council Bill be cited as approval for application to the United States Department of Housing and Urban Development for the Tribal Housing and Urban Development- Veterans Administration Supportive Housing Grant.
