TO APPROVE FUNDING FOR THE ACQUISITION OF REAL PROPERTY AT DAISY RANCH

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE funding for the acquisition of real property at Daisy Ranch.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Tribal Council of the Nation (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS, the Nation has the opportunity to purchase approximately 20 acres of real property (the "Real Property"), located at N/2 SW NE of Section 5, Township 2 North, Range 16 East, Pittsburg County, Oklahoma, and located within the existing boundaries of the Nation's Daisy Ranch;

WHEREAS, the purchase price for the Real Property is Fourteen Thousand Dollars (\$14,000);

WHEREAS, the Council has determined that it is in the best interests of the Nation to purchase the Real Property for Fourteen Thousand Dollars (\$14,000) plus all ordinary and customary closing costs (collectively, the "Purchase Price");

THEREFORE, BE IT ENACTED by the Council that this Bill be cited as approval for the funding of the Purchase Price for the purchase of the Real Property.

BE IT FURTHER ENACTED by the Council that this Bill be cited as approval that the funding for the Purchase Price shall come from unrestricted cash.
