

**TO DESIGNATE THE CHOCTAW NATION TRIBAL COMPLEX LOCATED AT 529 NORTH 16<sup>TH</sup> AVENUE, DURANT, OKLAHOMA, AS THE "CHIEF GREGORY E. PYLE TRIBAL COMPLEX"**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO DESIGNATE** the Choctaw Nation Tribal Complex, located at 529 North 16th Avenue, Durant, Oklahoma, as the "Chief Gregory E. Pyle Tribal Complex."

**WHEREAS**, Gregory E. Pyle served as the Assistant Chief of the Choctaw Nation for more than 13 years;

**WHEREAS**, Gregory E. Pyle proudly served as Chief of the Choctaw Nation from 1997 to 2014; and

**WHEREAS**, Chief Gregory E. Pyle was inducted into the Oklahoma Hall of Fame in 2007 and received a host of honors and awards for his service to the Choctaw Nation and the state of Oklahoma.

**THEREFORE BE IT ENACTED**, by the Tribal Council of the Choctaw Nation of Oklahoma, that this bill be cited as the designation of the Choctaw Nation Tribal Complex, located at 529 North 16th Avenue, Durant, Oklahoma, as the "Chief Gregory E. Pyle Tribal Complex."


**BE IT FURTHER ENACTED** by the Tribal Council that the Choctaw Nation Tribal Complex, located at 529 North 16th Avenue, Durant, Oklahoma, shall after the date of enactment of this bill, be known as the "Chief Gregory E. Pyle Tribal Complex."

**BE IT FURTHER ENACTED** that any reference in any law, regulation, map, document, paper, or other record of the Choctaw Nation of Oklahoma to the tribal complex located at 529 North 16th Avenue, Durant, Oklahoma, shall be deemed to be a reference to the "Chief Gregory E. Pyle Tribal Complex."

**CERTIFICATION**
