#### RONALD PERRY INTRODUCED THE FOLLOWING BILL

#### A COUNCIL BILL

**TO APPROVE** an amendment to a service line agreement, in favor of Oklahoma Natural Gas Company, a division of ONE Gas, Inc., on land held by the USA in Trust for the Choctaw Nation of Oklahoma in Bryan County, Oklahoma.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation;

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, the Tribal Council (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS, on April 10, 2021, the Council passed CB-51-20, a bill approving a Service Line Agreement, in favor of Oklahoma Natural Gas Company, to provide a meter for natural gas service for the Choctaw Nation Casino pool expansion project in Durant, Oklahoma. See Exhibit C;

WHEREAS, the original survey, dated March 1, 2021, states the 10' gas easement will cover an area described as 0.08 acres. See Exhibit E;

WHEREAS, Oklahoma Natural Gas Company now proposes to amend the location of the service line agreement and the 10-foot wide easement now cover 0.086 acres. See Exhibit B; and

WHEREAS, the Tribal Council has determined it is in the best interest of the Choctaw Nation of Oklahoma to approve the amendment to the Service Line Agreement in favor of Oklahoma Natural Gas Company pursuant to Exhibit A.

THEREFORE BE IT ENACTED by the Tribal Council that this Bill be cited as approval of the proposed amendment to the Service Line Agreement for a perpetual term, described as being in Section 13, Township 7 South, Range 8 East, Bryan County, OK (See Page 1 of Exhibit A), in favor of Oklahoma Natural Gas Company, on land held by the USA in Trust for the Choctaw Nation of Oklahoma.

**BE IT FURTHER ENACTED** by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.

Applicant agrees to comply with all the applicable requirements of 25 CFR 169 Subpart B.


