## RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

**TO APPROVE** application to the United States Department of Health and Human Services, Administration for Children and Families, Administration for Native Americans for the Environmental Regulatory Enhancement grant funding opportunity: HHS-2021-ACF-ANA-NR-1907.

WHEREAS, the Choctaw Nation (the "Nation") acknowledges the Environmental Regulatory Enhancement (ERE) grant program will be used to create environmental codes, create training documents and outreach materials, and conduct training and outreach to tribal members as well as Nation associates;

WHEREAS, funds from the ERE grant will be used to develop and expand knowledge of tribal codes to all tribal facilities, CNO associates, and members to strengthen the sovereignty and environmental presence of the tribe;

WHEREAS, the Nation is applying for up to \$200,000 in funding from the ERE grant program with a required match of up to \$50,000 for a total budget of \$250,000;

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma finds it is in the best interest of the Nation to approve application to the ERE grant program.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for application to the United States Department of Health and Human Services for Environmental Regulatory Enhancement Grant.

**BE IT FURTHER ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to allocate up to \$50,000 for a required match if awarded funds from the Environmental Regulatory Enhancement Grant.

**BE IT FURTHER ENACTED** by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
