TO APPROVE application to the U.S. Department of Health and Human Services for the Family Violence Prevention Grant for FY2022.

WHEREAS, the purpose of the Family Violence Prevention Grant is to assist Tribes in efforts to increase public awareness about, and primary and secondary prevention of, family violence, domestic violence, and dating violence, and to provide immediate shelter and supportive services for victims of family violence, domestic violence, or dating violence, and their dependents;

WHEREAS, funds from this grant will help provide domestic violence services, outreach, awareness, and prevention to the Choctaw Nation of Oklahoma;

WHEREAS, if awarded, the Nation will continue to provide a Family Violence Prevention Program for members of the Nation;

WHEREAS, the Family Violence Prevention Program assisted over 300 victims of family violence, domestic violence, or dating violence with immediate shelter and supportive services this past year;

WHEREAS, with the rapid expansion of the Choctaw Nation, a Family Violence Prevention Program is needed to aid women, men, and children who are victims of family violence, domestic violence and dating violence; and

WHEREAS, the Tribal Council finds it is in the best interest of the Nation to approve application to the U.S. Department of Health and Human Services for the Family Violence Prevention Grant for FY2022.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for application to the Department of Health and Human Services for the Family Violence Prevention Grant for FY2022.
