

**TO APPROVE FUNDING FOR AN EQUITY INVESTMENT IN
A RESTAURANT TO BE LOCATED IN ATOKA, OKLAHOMA**

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE Funding for an Equity Investment in a Restaurant to be Located in Atoka, Oklahoma.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Tribal Council of the Nation (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS, the Nation has the opportunity to invest in a new restaurant (the "Restaurant") to be built in Atoka, Oklahoma;

WHEREAS, the Council has determined that it is in the best interests of the Nation to approve funding in the amount of Three Million Dollars (\$3,000,000) (the "Equity Investment Amount") to be used for an equity investment (the "Equity Investment") in the entity that will own and operate the Restaurant;


WHEREAS, the Council has determined that it is in the best interests of the Nation to fund the Equity Investment Amount from unrestricted cash.


THEREFORE, BE IT ENACTED by the Council that this Bill be cited as approval for the funding of the Equity Investment Amount.


BE IT FURTHER ENACTED by the Council that this Bill be cited as approval that the funding for the Equity Investment Amount shall come from unrestricted cash.
