 - No new updates from Marketing and Communications.
 - Mail in BallotPak (Proof 2) was submitted to Automated Election Services (AES) with one correction on May 26th. The Secretary stated that once the correction to the voting sticker was made then ballot proof 2 should be considered finalized.
 - A paper copy of Mail in BallotPak (Proof 2) was provided to the Board.
 - Planning details for the Voting Location Board Training (Unconfirmed Date) were discussed by the Board.
 - Secretary has contacted Automated Election Services (AES) on May 25th to request Voting Location Board Training on July 1st (1st preference) or June 30th (2nd preference); and requested that the Board review training materials provided by AES prior to the training. The Board is waiting on confirmation from vendor.
 - Planning details for the Election Board Command Center (7/8/2021 7/17/2021) were discussed by the Board.
 - Secretary confirmed new planning details for Hearing Room 1 with Judicial on June 1st.
 - No updates were made to the Election Board Meeting Schedule for 2021.
 - A paper copy was provided to the Board.
 - An overview of current activities that are ongoing with the CNO Voter Registration (VR)
 Department:
 - As of June 1st, we have a total of 41,681 registered voters which is 25.83% of the eligible tribal membership.
 - There are 5,414 total registered voters in Council Districts 4, 7, and 10. This
 number has been communicated to Automated Election Services so that they
 can begin preparing materials to mail ballots.
