A COUNCIL RESOLUTION

TO APPROVE a resolution supporting the nomination and appointment of Chief Gary Batton to serve as member of the U.S. Department of Housing and Urban Development-Tribal Intergovernmental Advisory Committee.

TO APPROVE a resolution supporting the nomination and appointment of Bobby Yandell, Executive Director of the Housing Authority of the Choctaw Nation of Oklahoma, to serve as an alternate member of the U.S. Housing and Urban Development-Tribal Intergovernmental Advisory Committee.

WHEREAS the U.S. Department of Housing and Urban Development (HUD) has solicited nominations for the newly created Tribal Intergovernmental Advisory Committee (the "Committee");

WHEREAS Chief Gary Batton desires to serve as a member of the Committee and represent the Choctaw Nation, tribal members, and all of Indian Country;

WHEREAS Chief Gary Batton desires to appoint Bobby Yandell, Executive Director of the Housing Authority of the Choctaw Nation, as an alternate member of the Committee;

WHEREAS the Tribal Council desires to build our Nation-to-Nation relationship with the United States of America, grow our partnership with HUD, and learn from other tribal nations to better address housing needs in Indian Country; and

WHEREAS the Tribal Council finds it is in the best interest of the Choctaw Nation to support the nomination and appointment of Chief Gary Batton as a member of the Committee and the nomination of Mr. Yandell as an alternate member to the Committee.

THEREFORE BE IT RESOLVED by the Tribal Council of the Choctaw Nation of Oklahoma that this resolution be cited as approval of the nomination and appointment of Chief Gary Batton to serve as a member of the U.S. Department of Housing and Urban Development-Tribal Intergovernmental Advisory Committee.


