## TO NAME THE BROKEN BOW CLINIC THE RUBY CHOATE CLINIC

# IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

**TO APPROVE** naming the Broken Bow Clinic the *Ruby Choate Clinic*.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, "The Tribal Council shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property";

WHEREAS, Ruby Choate was a longtime associate of the Broken Bow Clinic and is deserving of the recognition and distinction of having the Broken Bow Clinic named in her honor for her service to the Broken Bow Clinic, its patients, faculty and staff, and the community and for her service in the U.S. Navy; and

WHEREAS, the Tribal Council (the "Council") of the Choctaw Nation of Oklahoma (the "Nation") has determined that it is in the best interests of the Nation to name the Broken Bow Clinic the *Ruby Choate Clinic* to show appreciation and pride in our veterans and in those who go beyond the call and serve tribal members, patients, faculty and staff at the Broken Bow Clinic and the community, as Ruby Choate did for more than 20 years.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as the naming of the Broken Bow Clinic the Ruby Choate Clinic and the building shall have its new name affixed above the entrance.

**BE IT FURTHER ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
