A COUNCIL BILL

TO APPROVE the funds and budget from the United States Department of Housing and Urban Development for the FY21 Indian Community Development Block Grant - American Rescue Plan Act (ICDBG-ARP).

WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") has been awarded a grant from the United States Department of Housing and Urban Development ("HUD") for budget period March 14, 2022 through February 28, 2023, in the amount of \$3,325,700.00 to rehabilitate 82 Affordable Rental ("AR") units. See Exhibit A;

WHEREAS, the federal budget for ICDBG-ARP is \$3,325,700.00 with no required match;

WHEREAS, funds will rehabilitate 82 AR homes by upgrading windows, doors, and HVAC systems to prevent, prepare and respond to COVID-19; and

WHEREAS, the Tribal Council finds it is in the best interest of the Nation to approve the funds and budget for the Indian Community Development Block Grant - American Rescue Plan to provide rehabilitated Affordable Rental units to the Nation and its Members.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept Three Million, Three Hundred Twenty-Five Thousand, Seven Hundred Dollars and 00/100 (\$3,325,700.00) from the United States Department of Housing and Urban Development for the Indian Community Development Block Grant – American Rescue Plan for budget period March 14, 2022 through February 28, 2023.
