

**TO APPROVE THE PURCHASE OF REAL PROPERTY LOCATED AT
808 DALLAS STREET, TALIHINA, OKLAHOMA**

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the purchase of real property located at 808 Dallas Street, Talihina, Oklahoma.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Nation's Tribal Council (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition and management of real property;

WHEREAS, the Nation seeks to acquire real property for the purpose of promoting the general welfare of its people and taking further advantage of opportunities for self-determination and economic independence;

WHEREAS, the Council has determined that it is in the best interests of the Nation to purchase real property consisting of 2.81 acres of land and all improvements thereon located at 808 Dallas Street in Talihina, LeFlore County, Oklahoma (the "Property"), including one block building totaling 1,584 square feet, and certain associated fixtures and equipment, for up to Six Hundred Seventy-Five Thousand Two Hundred Dollars (\$675,200) (the "Acquisition Cost"), which amount includes the purchase price, demolition and site clean-up costs, and usual and customary due diligence and closing costs; and

WHEREAS, the Council has determined that it is in the best interests of the Nation to fund the Acquisition Cost from unrestricted funds.


THEREFORE, BE IT ENACTED by the Council that this Bill be cited as approval to purchase the Property, and to make related expenditures as discussed above, for the Acquisition Cost.


BE IT FURTHER ENACTED by the Council that this Bill be cited as approval that the funding for the Acquisition Cost shall come from unrestricted funds.


