### IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

### RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

### A COUNCIL BILL

**TO RESCIND** CB-22-22, a council bill approving the capital expenditure for the renovation for the Wilburton Community Center; and

**TO APPROVE** an allocation of Nine Million Ninety-Six Thousand Three Hundred Eighty-One Dollars (\$9,096,381.00) for the renovation of the Wilburton Community Center.

WHEREAS, in CB-22-22, the Tribal Council of the Choctaw Nation of Oklahoma (the "Tribal Council") determined it was in the best interest of the Choctaw Nation to establish a new community center in Wilburton. See Exhibit A;

WHEREAS, the Tribal Council approved the expenditure of \$8,018,001.00 for the renovation of the Wilburton Community Center in CB-22-22. See Exhibit A;

WHEREAS, Choctaw Nation of Oklahoma Business Development has received an updated renovation budget for the Wilburton Community Center in the amount of \$9,096,381.00, which is an increase of \$1,078,380.00 or 13.4% of the original cost. See Exhibit B;

WHEREAS, the increase in cost is due to inflation throughout the construction industry and is below the national inflation average. See Exhibit B; and

WHEREAS, the increase in renovation costs of the new facility will greatly increase the office space available for multiple Nation departments and employees and significantly increases the storage space for equipment, thereby substantially improving the effectiveness and efficiency of departments and staff as outlined in Exhibit B.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for the rescission of CB-22-22.

**BE IT FURTHER ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to allocate Nine Million Ninety-Six Thousand Three Hundred Eighty-One Dollars and 00/100 (\$9,096,381.00) for the renovation of a Community Center in Wilburton, Oklahoma.

**Purpose/Need of Council Bill:** In CB-22-22, the Tribal Council allocated funds for the renovation of a new community center in Wilburton. After evaluating the existing plans and receiving revised bids, Tribal Renovation and Business Development have determined that the budget for the original scope of the project has increased from \$8,018,001.00 to \$9,096,381.00, which is an increase of \$1,078,380.00 or 13.4% of the original project cost. These increases are due to inflation in the renovation industry. See Exhibit B.

### RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

TO APPROVE the capital expenditure for the renovation of the former Merit Energy property in Wilburton, Oklahoma for a new Community Center.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, "The Tribal Council shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property";

WHEREAS, on December 12, 2020, Council approved the purchase of the former Merit Building with the purpose of making it a new Community Center and office building. In March, 2021, the Nation purchased the former Merit Building for use as a Community Center and as offices for Tribal Services, Information Technology, Tribal Police, Tribal Council, Commerce and other tribal departments; and

WHEREAS, the Tribal Council (the "Council") of the Choctaw Nation of Oklahoma (the "Nation") has determined that it is in the best interests of the Nation to make a capital expenditure in the amount of \$8,018,001.00 for the renovation and site development of the former Merit Building.

THEREFORE, BE IT ENACTED by the Council that this Bill be cited as approval of funds to renovate a commercial building and real property for use as a Community Center and Office Building with parking lot and site development located at 1455 N.W. Highway 2, Wilburton, Oklahoma for Eight Million Eighteen Thousand One Dollars (\$8,018,001.00).

BE IT FURTHER ENACTED by the Council that this Bill be cited as approval to renovate the commercial building and real estate at: Lots 10 & 11 in Townsite Addition Number 5, Section 6, Range 5 North, Range 19, East of the IBM, Latimer County, Oklahoma ADD #5 12.45A Lot 10, 7.52 A Lot 11,581/272-86 (property address: 1455 NW HWY 2, Wilburton, Oklahoma 74578).

BE IT FURTHER ENACTED by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.

Purpose/Need of Council Bill: To approve the funds to renovate a 19,552 square-foot commercial building and develop portions 19.97 acres of land at 1455 Northwest Hwy 2, Wilburton, OK 74578 for a new Community Center with office space and a parking lot. If the funds are approved, the building will be used for a new community center.
