#### A COUNCIL BILL

TO PROCLAIM the second Monday of each October as Indigenous Peoples' Day.

Date 10-12-22

WHEREAS, in accordance with Article IX, Section 4 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Tribal Council of the Nation (the "Tribal Council") is authorized to enact legislation, rules and regulations for the general good of the Nation and for the administration and regulation of the affairs of the Nation; and

WHEREAS, the Tribal Council has determined that it is in the best interests of the Nation to proclaim the second Monday of October as *Indigenous Peoples' Day* in order to appropriately honor and pay respect to the Indigenous Peoples across the Americas and to appreciate the Indigenous cultures and histories.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited the proclamation that the second Monday of October is hereby declared as *Indigenous Peoples' Day*, effective immediately.
