

**TO APPROVE FUNDING FOR RENOVATIONS AT
CHOCTAW VILLAGE SHOPPING CENTER IN IDABEL, OKLAHOMA**

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE Funding for Renovations at Choctaw Village Shopping Center in Idabel, Oklahoma.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Nation's Tribal Council (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition and management of tribal property;

WHEREAS, the Nation owns the Choctaw Village Shopping Center (the "Shopping Center") in Idabel, Oklahoma;

WHEREAS, certain space within the Shopping Center (the "Renovation Space") needs to be renovated;

WHEREAS, the renovation of the Renovation Space will cost up to Six Hundred Ninety Five Thousand Eight Hundred Thirty Seven Dollars (\$695,837) (the "Renovation Cost");

WHEREAS, the Council has determined that it is in the best interests of the Nation to renovate the Renovation Space in order to improve the quality of shopping available to Tribal members; and

WHEREAS, the Council has determined that it is in the best interests of the Nation to fund the Renovation Costs from unrestricted funds.


THEREFORE, BE IT ENACTED by the Council that this Bill be cited as approval for the funding of the renovation costs in the amount of up to Six Hundred Ninety Five Thousand Eight Hundred Thirty Seven Dollars (\$695,837) (the "Renovation Cost") to renovate the Renovation Space.


BE IT FURTHER ENACTED by the Council that this Bill be cited as approval that the Renovation Costs shall be funded from unrestricted funds.
