WHEREAS, the U.S. Department of the Treasury solicits nominations for the Treasury Tribal Advisory Committee ("TTAC");

WHEREAS, in accordance with Article VII, Section 2 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief has the power to "establish and appoint committees, members and delegates to represent the Choctaw Nation with the advice and consent of the Tribal Council.";

WHEREAS, Chief Gary Batton desires to nominate Martin Tucker, Choctaw Nation Chief Financial Officer, to serve in this role to represent the Nation, our communities, our tribal members, and Indian Country as a whole;

WHEREAS, Martin's credentials and leadership within the Nation's financial management, his service to our country as a veteran, and his years of banking and financial expertise will add unique and valuable knowledge to the Treasury Tribal Advisory Committee;

WHEREAS, the Tribal Council of the Nation supports efforts to build and grow our Nation-to-Nation relationship with the United States of America, grow our relationship and partnership with the U.S. Department of the Treasury and its leadership, as well as build strong relationships with other tribal nations;

WHEREAS, Martin Tucker is highly qualified and equipped to serve on this committee due to his stewardship of the Nation's financial resources, his adept skills in management and financial planning, his ability to lead and manage employees, all in an effort to serve one of the largest Tribal Nations in the United States;

WHEREAS, Martin maintains professional credentials to preserve and uphold the integrity of his role within the Nation, which enhances his unique ability to serve the sound financial needs of our tribal government, businesses, and tribal members in Oklahoma, the United States, and around the world; and

WHEREAS, the Tribal Council has determined it is in the best interest of the Nation to support the nomination of Martin Tucker to serve on the United States Department of the Treasury Tribal Advisory Committee as a representative of the Nation.
