#### A COUNCIL BILL RESCINDING CB-033-89 RELATING TO COMMUNITY CENTERS

# IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

**TO RESCIND** CB-033-89, which relates to the management of community centers of the Choctaw Nation of Oklahoma.

WHEREAS, Article IX, Section 4 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation") provides that the Tribal Council (the "Council") shall enact legislation, rules and regulations not inconsistent with the Constitution for the general good of the Choctaw Nation and for the administration and regulation of the affairs of the Choctaw Nation;

WHEREAS, the Nation has evolved over the years into a complex and robust government with policies and laws in place that reflect the Nation's complexity and intent to modernize how the Nation operates while still respecting and providing for the needs of the Nation's Tribal Members;

WHEREAS, CB-033-89, attached hereto as Exhibit A, is an obsolete law that no longer reflects the Nation's current operation and management of community centers due to the evolution of the Nation into a complex and robust government;

WHEREAS, the Council recognizes the need to rescind CB-033-89 in order to modernize the management of community centers and accommodate to the Nation's current needs; and

WHEREAS, the Council finds it is in the best interest of the Nation to adapt and accommodate to the everchanging and evolving needs of the Nation and its Tribal Members by rescinding CB-033-89, attached as Exhibit A.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for rescinding CB-033-89, attached as Exhibit A, effective immediately.
