#### A COUNCIL BILL

**TO APPROVE** the donation of surplus vehicles with an original cost of \$77,527.67, a net book value of 0, and a fair-market value of \$9,252.00 including all listed inventory as attached in Exhibit A.

WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") via the Donations Committee, has received a request from the Calvin Police Department for a donation of patrol vehicles;

WHEREAS, the Donations Committee has evaluated the request and the Nation's current law enforcement fleet and determined that the Nation has surplus patrol vehicles that have exceeded their useful life to the Nation as listed in attached Exhibit A;

WHEREAS, the donation of the patrol vehicles will increase public safety on the Choctaw Nation Reservation, as the Calvin Police Department is located within the Choctaw Nation Reservation and serves many Choctaw Members who reside in the City of Calvin. The Calvin Police Department also has a cross-deputization agreement with the Nation; and

WHEREAS, the Tribal Council has determined it is in the best interest of the Nation to approve the donation of surplus vehicles as listed in Exhibit A.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to donate the vehicles listed in Exhibit A to the Calvin Police Department in Calvin, Oklahoma.
