RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

A COUNCIL RESOLUTION

TO APPROVE a Resolution supporting Coal County General Hospital (CCGH) in its application to the United States Department of Agriculture (USDA) for a Distance Learning & Telemedicine Grant;

WHEREAS, CCGH provides healthcare to many Choctaw Nation Members in Coal County;

WHEREAS, the USDA is offering grant assistance to rural medical providers that will allow them to increase telemedicine services by purchasing or supporting audio, video, and interactive video equipment, computer hardware, software, and network components, and broadband facilities used for distance learning or telemedicine;

WHEREAS, the COVID-19 pandemic highlighted many rural healthcare delivery system flaws. As a result of the weaknesses identified by COVID-19, CCGH desires to apply for this grant to install telemedicine equipment in its hospital, three rural health clinics, and long-term care facility;

WHEREAS, CCGH also wants to donate telemedicine equipment to the most remote school districts in its service area to reduce student absenteeism when seeking healthcare appointments. The goal of this equipment is to provide greater access to care for CCGH's rural patient population through partnerships with other regional healthcare systems;

WHEREAS, CCGH has reached out to Choctaw Nation Health Services Authority leadership and asked for a resolution from the Nation supporting CCGH's application since CCGH is within the Choctaw Nation Tribal Statistical Area; and

WHEREAS, the Choctaw Nation Healthcare Services Authority wishes to support CCGH's application to increase telehealth services to the Coal County area and increase partnerships with other local rural healthcare providers.

THEREFORE BE IT RESOLVED by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for supporting the application of the Coal County General Hospital to the United States Department of Agriculture for a Distance Learning & Telemedicine Health Grant.


CERTIFICATION
