RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

A COUNCIL RESOLUTION

TO APPROVE a Resolution supporting the nomination of Dr. Jason Hill, Choctaw Nation Health Services Authority Chief Medical Officer, to serve as a member of the United States Department of Health and Human Services Council on Graduate Medical Education as a representative of the Choctaw Nation of Oklahoma.

WHEREAS, the United States Department of Health and Human Services (“HHS”) solicits nominations for the Council on Graduate Medical Education;

WHEREAS, in accordance with Article VII, Section 2 of the Constitution of the Choctaw Nation of Oklahoma (the “Nation”), the Chief has the power to “establish and appoint committees, members and delegates to represent the Choctaw Nation with the advice and consent of the Tribal Council.”;

WHEREAS, Chief Gary Batton nominates Dr. Jason Hill to serve as a member of the United States Department of Health and Human Services Council on Graduate Medical Education to represent the Nation, our physicians and residents, our healthcare system, our communities, Choctaw Nation Members, and Indian Country as a whole;

WHEREAS, Dr. Hill’s longtime leadership of the Choctaw Nation Health Services Authority, his dedication to training new physicians, and service to and focus on rural and tribal healthcare needs make him uniquely qualified to serve on the Council on Graduate Medical Education;

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma supports efforts to build and grow our Nation-to-Nation relationship with the United States of America, grow our relationship and partnership with the United States Department of Health and Human Services, as well as build strong relationships with other tribal nations, states, and the medical community to grow our healthcare services and meet the unique health needs of rural American Indians and Indian Country;

WHEREAS, Dr. Hill is highly qualified and equipped to serve on this committee due to his lifelong commitment to providing medical care and developing physicians in some of the most rural, hard to serve areas of the country. Dr. Hill has a pulse on workforce needs and healthcare services in Indian Country and rural America. Dr. Hill has developed programs and partnerships with Oklahoma State University and others to develop Choctaw tribal members and other residents to grow, learn, and serve on the Choctaw Nation Reservation. Dr. Hill has helped grow the Choctaw Nation Health Services Authority to meet the demands of the Nation’s rural population and geography. He will provide a unique and well-researched voice to this national role; and

WHEREAS, the Tribal Council has determined it is in the best interest of the Nation to support the nomination of Dr. Jason Hill to serve on the U.S. Department of Health and Human Services Council on Graduate Medical Education as a representative of the Nation.

THEREFORE BE IT RESOLVED by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for supporting the nomination of Dr. Jason Hill to serve on the United States Department of Health and Human Services Council on Graduate Medical Education.


