

TO APPROVE REVOCABLE PERMIT NO. G09-2043, IN FAVOR OF RALPH ALLRED, ON LAND HELD BY THE USA IN TRUST FOR THE CHOCTAW NATION OF OKLAHOMA IN CHOCTAW COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE Revocable Permit No. G09-2043, in favor of Ralph Allred, on land held by the USA in Trust for the Choctaw Nation of Oklahoma in Choctaw County, Oklahoma.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation;

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, the Tribal Council (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS, Ralph Allred has proposed a Revocable Permit to bale hay on land located in the NE¼ NE¼, lying East of the St. Louis San Francisco Railroad in Section 16, Township 6 South, Range 17 East, Choctaw County, Oklahoma, containing 20 acres, more or less. See Exhibit B for location map;

WHEREAS, the payment will be \$250.00 per year;

WHEREAS, the permit shall be for a Three (3) year term, beginning June 1, 2023. Hay baling will be performed from June 1st through September 30th of each year; and

WHEREAS, the Tribal Council has determined it is in the best interest of the Choctaw Nation of Oklahoma to approve the Revocable Permit, in favor of Ralph Allred.

THEREFORE BE IT ENACTED by the Tribal Council that this Bill be cited as approval of the proposed Revocable Permit No. G09-2043, located in Section 16, Township 6 South, Range 17 East, Choctaw County, OK, in favor of Ralph Allred, on land held by the USA in Trust for the Choctaw Nation of Oklahoma (See Exhibit A).


BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma, that this bill be cited for approval of the payment of \$250.00 per year for a three (3) year term, beginning June 1, 2023.

BE IT FURTHER ENACTED by the Tribal Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
