#### RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

#### A COUNCIL RESOLUTION

**TO APPROVE** a Resolution supporting the nomination of Kara Bacon, Choctaw Nation Tribal Prosecutor, to serve on the United States Sentencing Commission Tribal Issues Advisory Group as a representative of the Choctaw Nation of Oklahoma.

WHEREAS, the United Sates Sentencing Commission (USSC) solicits requests for applications for its Tribal Issues Advisory Group to provide recommendations on criminal sentencing and other criminal issues facing Indian Country;

WHEREAS, in accordance with Article VII, Section 2 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief has the power to "establish and appoint committees, members and delegates to represent the Choctaw Nation with the advice and consent of the Tribal Council.";

WHEREAS, Chief Gary Batton nominates Kara Bacon, Tribal Prosecutor and Choctaw tribal member, to serve on the United States Sentencing Commission Tribal Issues Advisory Group to represent the Nation, Choctaw Nation Members, and Indian Country as a whole;

WHEREAS, Mrs. Bacon's extensive professional experience as a prosecutor and her commitment to public safety and justice for victims make her extremely qualified for this role. During her tenure as Choctaw Nation Tribal Prosecutor, Mrs. Bacon has overseen a 2,750% increase in the Choctaw Nation's case load in the wake of the McGirt decision and has also established excellent working relationships with local, state, and federal law enforcement partners to ensure public safety on the Choctaw Nation Reservation;

WHEREAS, The United States Sentencing Commission, a bipartisan, independent agency located in the judicial branch of the federal government, was created by Congress in 1984 to reduce sentencing disparities and promote transparency and proportionality in criminal sentencing. The Commission collects, analyzes, and distributes a broad array of information on federal sentencing practices. The Commission also continuously establishes and amends sentencing guidelines for the judicial branch and assists the other branches of the federal government in developing effective and efficient criminal policy;

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma supports efforts to build and grow its Nation-to-Nation relationship with the United States of America, grow the Nation's relationship and partnership with the United States Sentencing Commission, and build strong relationships with law enforcement professionals of other tribal nations, states, and the federal government to meet the unique challenges and needs of Indian Country; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma has determined it is in the best interest of the Nation to support the nomination of Mrs. Kara Bacon to serve on the United States Sentencing Commission Tribal Issues Advisory Group as a representative of the Nation.

**THEREFORE, BE IT RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval supporting the nomination of Mrs. Kara Bacon to serve on the United States Sentencing Commission Tribal Issues Advisory Group.
