# IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

#### A COUNCIL RESOLUTION

TO APPROVE a Resolution appointing Joseph Jefferson to the Ethics Committee of the Choctaw Nation of Oklahoma.

WHEREAS, Article IX, Section 4 of the Constitution of the Choctaw Nation of Oklahoma provides that the Tribal Council (the "Council") shall enact legislation, rules and regulations not inconsistent with the Constitution for the general good of the Choctaw Nation and for the administration and regulation of the affairs of the Choctaw Nation;

WHEREAS, Chapter 8, Section 4 of the Choctaw Nation of Oklahoma Code of Ethics (the "Code") states that "[t]wo (2) members of the Ethics Commission shall be appointed by the Legislative Department[.]" See CB-55-21;

WHEREAS, in accordance with Chapter 8, Section 2 of the Code, "Ethics Commission members shall serve 4-year, staggered terms. The second appointment from each Department shall serve only a two-year term for the first term, then 4-year terms thereafter." See CB-55-21;

WHEREAS, pursuant to the Code, the Tribal Council of the Choctaw Nation of Oklahoma has selected Joseph Jefferson for appointment to the Ethics Committee of the Choctaw Nation; and

**WHEREAS**, the Tribal Council finds it is in the best interest of the Choctaw Nation of Oklahoma to appoint Joseph Jefferson to the Ethics Committee of the Choctaw Nation for a term of four years.

**THEREFORE BE IT RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval to confirm the appointment of Joseph Jefferson to the Ethics Committee of the Choctaw Nation for a term of four years.

**BE IT FURTHER RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for the appointment of Joseph Jefferson to the Ethics Committee to be effective immediately.
