A COUNCIL RESOLUTION

TO APPROVE a Resolution supporting the nomination of Amanda Johnson, Choctaw Nation Tribal Member and Executive Director of Education, to serve as a member of the Oklahoma Advisory Council on Indian Education as a representative of the Choctaw Nation of Oklahoma.

WHEREAS, the Oklahoma Advisory Council on Indian Education has an opening for an appointed by the Oklahoma State Speaker of the House of Representatives;

WHEREAS, in accordance with Article VII, Section 2 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief has the power to "establish and appoint committees, members and delegates to represent the Choctaw Nation with the advice and consent of the Tribal Council.";

WHEREAS, Chief Gary Batton nominates Amanda Johnson, Choctaw Nation Tribal Member and Executive Director of Education, to serve as a member of the Oklahoma Advisory Council on Indian Education to represent the Nation, its educational programs, Choctaw students, and all Native students in Oklahoma;

WHEREAS, Ms. Johnson's leadership, education, experience, and expertise, as well as her commitment to serving students make her a great fit for this role;

WHEREAS, Ms. Johnson is highly qualified and equipped to serve on this committee due to her commitment to serving the Nation and utilizing her skillset to provide tribal members with education opportunities from birth and through their lifetime. Ms. Johnson oversees programming that serves 38,000 tribal members nationwide, and has the skillset and heart to serve in this statewide capacity; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma supports efforts to build and grow our relationship with the State of Oklahoma, grow our relationship and partnership with other governments and educational institutions around the state, and build strong relationships with other tribal nations; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma has determined it is in the best interest of the Nation to support the nomination of Ms. Amanda Johnson to serve on the Oklahoma Advisory Council on Indian Education as a representative of the Nation.

THEREFORE, BE IT RESOLVED by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for supporting the nomination of Ms. Amanda Johnson to serve on the Oklahoma Advisory Council on Indian Education.


