#### IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

### RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

#### A COUNCIL RESOLUTION

TO APPROVE a Resolution supporting the nomination of Scott Freeny, Choctaw Nation Tribal Member and Senior Legal Director, to serve as a member of the United States Government Accountability Office Tribal and Indigenous Advisory Council, replacing the appointment of Sarah Curtis and to fulfill the remainder of her term, and any successive terms, if any.

WHEREAS, Sarah Curtis has diligently served as a member of the United States Government Accountability Office Tribal and Indigenous Advisory Council (the "Advisory Council") during the term of her employment at Choctaw Nation. Upon her resignation, Scott Freeny is nominated to serve in this role as a representative of the Choctaw Nation of Oklahoma;

WHEREAS, in accordance with Article VII, Section 2 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief has the power to "establish and appoint committees, members and delegates to represent the Choctaw Nation with the advice and consent of the Tribal Council.";

WHEREAS, Chief Gary Batton nominates Scott Freeny, Choctaw Nation tribal member and Senior Legal Director, to serve as a member of the Advisory Council to represent the Nation, our Choctaw Nation government, businesses, and Choctaw tribal members;

WHEREAS, Mr. Freeny's education, experience, and expertise as well as his commitment to serving the Nation and its businesses and people through sound legal processes make him an ideal candidate for this role;

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma supports efforts to build and grow the Nation's relationship with federal agencies to support and grow prosperous tribal nations and economies;

WHEREAS, Mr. Freeny is highly qualified and equipped to serve on this committee due to his commitment to serving tribal members. Mr. Freeny's leadership and expertise in tribal business and legal matters has helped to grow strong, resilient businesses. He also has specific expertise and involvement with the legal management of federal funding for the Nation, which will provide sound guidance and knowledge to the Advisory Committee; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma has determined it is in the best interest of the Nation to support the nomination of Mr. Scott Freeny to serve on the United States Government Accountability Office Tribal and Indigenous Advisory Council.

**THEREFORE**, **BE IT RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this resolution be cited as approval for supporting the nomination of Scott Freeny to serve on the United States Government Accountability Office Tribal and Indigenous Advisory Council.
