#### A COUNCIL RESOLUTION

TO NAME the Antlers Community Center the Jack Austin, Sr. Community Center.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), "The Tribal Council shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property";

WHEREAS, Jack Austin, Sr. dedicated decades of his life to serving the Nation and its people, earning the appreciation and admiration of those around him;

**WHEREAS**, Jack Austin, Sr. served for over 30 years in the Choctaw Nation Health Service and also served for 20 years on the Tribal Council of the Choctaw Nation of Oklahoma as the representative for District 7;

WHEREAS, in appreciation and acknowledgement of Mr. Austin's dedication and service, over 100 members of the Choctaw community in Antlers have signed on the attached exhibit to show their support for naming the Choctaw Community Center in Antlers the *Jack Austin Sr. Community Center* (See Exhibit A attached); and

**WHEREAS**, the Tribal Council of the Choctaw Nation of Oklahoma has determined it is in the best interest of the Nation to name the Antlers Community Center the *Jack Austin*, *Sr. Community Center* to show appreciation for Mr. Austin's decades of service and dedication to the Nation and its members.

**THEREFORE BE IT RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for naming the Antlers Community Center the *Jack Austin, Sr. Community Center* and the building shall have its new name affixed at the entrances.

**BE IT FURTHER RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver, and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
