# IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

**TO APPROVE** application to the Tribal Solar Accelerator Fund (TSAF) for the Facility-Residential Grant for the benefit of low to moderate income Tribal Members as well as tribally owned and maintained facilities.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, the Tribal Council (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS, the Choctaw Nation (the "Nation") recognizes the Housing Authority of the Choctaw Nation of Oklahoma (HACNO) as a Tribally Designated Housing Entity (TDHE) and authorizes HACNO to apply on behalf of the Nation for the TSAF Facility-Residential Grant;

WHEREAS, the TSAF Facility-Residential Grant program will serve Low to Moderate Income (LMI) households within the Choctaw Nation Reservation as well as facilities owned and operated on tribally owned lands. The funds received from this grant will be used to install solar panels to AR Homes and CNO facilities within the Choctaw Nation Reservation. The maximum available award amount from TSAF is \$200,000;

WHEREAS, this council bill supports the Nation's strategic goal of strengthening financial growth and economic stability while also supporting renewable energy goals by reducing the carbon footprint within the Choctaw Nation Reservation; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma has determined it is in the best interest of the Nation to authorize HACNO to apply to the Tribal Solar Accelerator fund for the Facility-Residential Grant and to provide approved solar modifications to residential homes on tribally owned lands.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for application to the Tribal Solar Accelerator Fund for the Facility-Residential Grant.
