## RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

#### A COUNCIL RESOLUTION

**TO APPROVE** a resolution supporting the nomination of Tasha Mitchell, Choctaw Nation Tribal Member and Senior Manager of Project EMPOWER, to serve as a member of the Oklahoma Domestic Violence Fatality Review Board.

WHEREAS, in accordance with Article VII, Section 2 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief has the power to "establish and appoint committees, members and delegates to represent the Choctaw Nation with the advice and consent of the Tribal Council";

WHEREAS, the Attorney General of the State of Oklahoma solicits nominations for members of the Oklahoma Domestic Violence Fatality Review Board;

WHEREAS, Chief Gary Batton nominates Tasha Mitchell, Choctaw Nation Tribal Member and Senior Manager of Project EMPOWER, to serve as a member of the Oklahoma Domestic Violence Fatality Review Board to represent the Nation, Choctaw Tribal Members, our communities, and Indian Country advocating for victims of Domestic Violence in Indian Country;

**WHEREAS,** Ms. Mitchell's experience and expertise, as well as her commitment to serving the Nation and its Tribal Members, make her well qualified for this role;

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma supports efforts to build and grow the Nation's relationship with the Attorney General of the State of Oklahoma as well as other tribal, state, and local governments involved in preventing domestic violence and advocating for victims;

WHEREAS, Ms. Mitchell is highly qualified and equipped to serve on this committee due to her commitment to serving our Tribal Members, and she has served victims on the Nation's Reservation for more than 15 years. Ms. Mitchell also has the support of her peers from the Native Alliance Against Violence to serve in this position. Ms. Mitchell is well-versed in federal and state programming and funding to support victims of intimate partner violence, as well as services for victims of all crimes; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma has determined it is in the best interest of the Nation to support the nomination of Ms. Tasha Mitchell to serve on the Oklahoma Domestic Violence Fatality Review Board as a representative of the Choctaw Nation of Oklahoma.

**THEREFORE, BE IT RESOLVED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Resolution be cited as approval for supporting the nomination of Tasha Mitchell to serve on the Oklahoma Domestic Violence Fatality Review Board.
