

**TO APPROVE THE SALE OF CERTAIN ASSETS**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL**

---

**A COUNCIL BILL**

**TO APPROVE** the sale of certain assets.

**WHEREAS**, in accordance with Article IX, Section 6 of the Constitution of The Choctaw Nation of Oklahoma (the “Nation”), the Tribal Council of the Nation (the “Council”) shall make decisions pertaining to the acquisition, leasing, disposition and management of tribal property;

**WHEREAS**, the Nation has two airplanes, one (1) 1993 Beechcraft C90B and one (1) 2004 Cessna Citation Encore (each, and collectively, the “Property”), that have reached the end of their useful lives and that need to be disposed of;

**WHEREAS**, the Nation has engaged Bare Planes, LLC (“Broker”), as its broker to sell the Property;

**WHEREAS**, the Tribal Council has determined it is in the best interest of the Nation to approve the sale of the Property, with the net proceeds from the sale of the Property being placed into the Nation’s general fund.

**THEREFORE, BE IT ENACTED** that this Bill be cited as approval to sell the Property at the price and upon the terms and conditions as approved by the Chief of the Nation, in his reasonable discretion.

**BE IT FURTHER ENACTED** that this Bill be cited as approval that the Aircraft Listing Agreements between the Nation and the Broker dated October 21, 2024, are hereby adopted, ratified, confirmed, and approved in all respects and for all purposes as the acts and deeds of the Nation.


**BE IT FURTHER ENACTED** that this Bill be cited as approval that all net proceeds from the sale of the property shall be placed into the Nation’s general fund.



**CERTIFICATION**


