The meeting was called to order by Chairperson, Virginia Kay Green.

Secretary Perkins provided the following information to the Board:

- Operational Updates including:
 - Legal and Compliance:
 - As of June 5, 2024, Secretary Perkins spoke with Jacob Keyes, CNO Legal Division. Jacob clarified that the format of the Chief and Tribal Council Election Ordinance has changed to fall in line with Title 125: Governmental Public Administration Codification Authorization Act (Copy Provided). The ordinance is referred to as Choctaw Statutes, Title 95: Elections: Chief and Tribal Council Election Ordinance. While the format changed, the content remains the same and is now easier to identify different Council Bills that created it (Copy Provided).
 - A change recommendation from the CNO Legal Division to rename the official document from the Chief and Tribal Council Ordinance to the Elections Code has been given to Secretary Perkins.

 As of June 26, 2024, Secretary Perkins confirmed approval to use Judicial Center as the Tabulation Location with Paula Talley and Judge Pierce for General Election 2025. The confirmed dates are as follows:

General Election -

Thursday, July 10, 2025 - tabulation setup

Friday, July 11, 2025 - Early Voting; ballots on property starting at 4pm

Saturday, July 12, 2025 - General Election; ballots on property

Sunday, July 13, 2025 through Friday, July 18, 2025 – ballots on property; ballots will be transported to storage on Friday.

Run-off Election -

Thursday, August 7, 2025 - tabulation setup

Friday, August 8, 2025 - Early Voting; ballots on property starting at 4pm

Saturday, August 9, 2025- Run-off Election; ballots on property

Sunday, August 10, 2025 through Friday, August 15, 2025 – ballots on property; ballots will be transported to storage on Friday.

- As of July 12, 2024, the business reply mail permit fee and annual maintenance fee
 were paid for the year to United States Postal Services (USPS). In addition, there is
 new Postmaster being hired for the Durant Post Office. Secretary Perkins will
 begin trying to initiate contact in January 2025.

- An overview of current activities that are ongoing with the CNO Voter Registration (VR):
 - Reminder that tribal members can view their voter registration information (phase I of OVR) on Chahta Achvffa Member Portal: https://chahtaachvffa.choctawnation.com/.
 - Go to the Voter Information tab on the landing page.
 - If the tribal member is not a registered voter, then they will see a message that directs members how to register to vote for the first time.
 - The 2nd phase of Online Voter Registration (OVR) on Chahta Achvffa went live on August 1, 2024 (Copy Provided). This will allow registered voters only to change the following information electronically:

Physical address for U.S. domestic addresses only.

Mailing address for U.S. domestic addresses only.

Primary and/or secondary phone number.

Email address.

Response to the Address Release Authorization.

 OVR will be unavailable for a 2-week period starting the Sunday prior to a tribal election day through the Saturday following a tribal election day so that it does not

conflict with the Same Day Registration process and data collection following election day.


- Future changes to fully achieve OVR for the Choctaw Nation of Oklahoma are subject to change but include the following:
 - Phase 3 Voter Registration wants to allow current registered voters who reside outside of the reservation to affiliate with a Council District. This is a restricted and audited process.
 - Phase 3 Voter Registration wants to allow current registered voters to change an international or military (APO and FPO) residential or mailing address.
 - Phase 3 Voter Registration wants to allow current registered voters to cancel their registration. This will require a document upload.
 - Phase 4 Voter Registration wants to allow notification of deceased voters. This will require more collaboration with Tribal Membership as TM is the official system of record for tribal member information and Voter Registration will defer to their process. VR does not change demographic information for tribal members which includes: First Name, Middle Name, Last Name, Birth Date, SSN4, or Gender.
 - Phase 4 Voter Registration wants to register new voters electronically. This requires a signature and may not be achievable.
 - Phase 4 Voter Registration wants to allow current registered voters to change married names and Suffix. This requires a signature and may not be achievable.
 Process may be collaborative with Tribal Membership.
- As of August 14, 2024, we have a total of 50,877 registered voters which is 28.57% of the tribal membership eligible to vote.
