The meeting was called to order by Chairperson, Virginia Kay Green.

SECRETARY'S REPORT

Secretary Perkins provided the following information to the Board:

- Financial Updates including:
 - A summary financial snapshot of FY25 operating expenses for cost center.
 - A budget cycle timeline for planning the FY26 budget was provided.
- Strategic Updates including:
 - Election Management System (project with Information Technology):
 - Go live was August 1, 2024.
 - Phase 2 Go Live was February 10, 2025, which included calendar, task, and asset inventory functions.
 - On hold until after the 2025 election cycle.
- Operational Updates including:
 - Legal and Compliance:
 - On January 15, 2025, General Counsel for the Choctaw Nation of Oklahoma, Renley Dennis of Whitten Burrage Law, submitted CB-24-25 containing amendments to the Choctaw Nation's Election Ordinance to Benjamin L Daniels, BIA Superintendent at Talihina Agency. Pursuant to the Principal Chiefs Act of 1970 (Pub.L. 91-495, 84 Stat. 1091), we are requesting approval of the attached amendments from the Secretary of Interior.
 - On February 6, 2025, Benjamin L. Daniels confirmed that he will submit CB-24-25 to the Regional Office as soon as possible.
 - On March 17, 2025, Secretary Perkins received notification that CB-24-25 was approved by the BIA. (Copy Provided)
 - A copy of the approved Election Ordinance is pending publication on the Choctaw Nation website.
 - On March 31, 2025, Secretary Perkins met with the Senior Director of Audit, Compliance, and Ethics to discuss the complaint review process used in EthicsPoint. Since the amended Election Ordinance requires notarization on some complaints then the Election Board will no longer use EthicsPoint. It was agreed that individuals who try to report Tribal Election concerns through EthicsPoint will receive the following message: Yakoke for your report. Election concerns are not reviewed through the EthicsPoint system, and no further action will be taken for this report through EthicsPoint. If you would like further information on how to



submit an inquiry or complaint regarding issues with tribal elections, please reach out to electionboard@choctawnation.com.

- On April I, 2025, the public received notification that Ron Perry, Council Member District 5, had resigned his office and that the resignation took effect immediately. There are two (2) years remaining on the term which results in a Special Election.
 - On behalf of the Board, Secretary Perkins contacted General Counsel and the Board's external legal counsel to begin discussing options to fill the vacant seat in Council District 5. Key points from legal counsel:
 - Article XXV, Section I states that Chief must officially call for a Special Election. Chief Batton complied by sending the Election Board an official notice on April 3, 2025.
 - Article XXI, Section 3 states that "The Secretary shall designate the dates for special elections, including the date of the election which shall be on a Saturday and the filing period which shall be the three (3) days (Monday, Tuesday and Wednesday) beginning on the twelfth (12th) Monday preceding the election, and provide sufficient notice to voters." This section supports the option that the General Election and Special Election may run concurrently on the same timeline this year. The goal of the Special Election is to ensure that District 5 has a representative to support their needs as soon as possible.
 - Council District 5 will be in its regular rotation for the next General Election in 2027.
 - Secretary Perkins contacted the Information Technology teams for Choctaw Nation and Automated Election Services to determine a variety of timeline options for the General Election and Special Election.
 - Secretary Perkins contacted the Election Board to let all know about the vacant seat in Council District 5.
 - On April 4, 2025, the Election Board held a Special Meeting to discuss public notices for Special Election dates. Public meeting minutes are documented for this date.

 - On February 10, 2025, Secretary Perkins requested a mock election in March 2025 with Automated Election Services. The goal of the mock election is to open communication channels between the new CNO development team and the AES development team and allow the CNO development team to see election processes in a test environment. Request is pending date confirmation from Terry Rainey.




- Facility Management:

 - On April 8, 2025, Secretary Perkins confirmed who will be the point of contact (POC) in Human Resources for CNO employment checks on prospective candidates. POC is noted on the Qualification Checklist used by the Election Board.
 - On April 8, 2025, Secretary Perkins confirmed who will be the point of contact (POC) in Tribal Membership to verify tribal membership status and blood quantum on prospective candidates. POC is noted on the Qualification Checklist used by the Election Board.

- An overview of current activities that are ongoing with the CNO Voter Registration (VR):
 - On January 6, 2025, VR released its Voter Registration Mail Drive which included 1,405 packets to new tribal members identified between January 1, 2024, to December 30, 2024.
 - We have response rate of 2.42% or 34 forms received. (No change from last report)
 - As of April 9, 2025, we have a total of 51,069 registered voters which is 28.25% of the tribal membership eligible to vote.
